Buccaneer Days & Esquimalt RibFest:

The Esquimalt Alumni Association coordinated the efforts of its members along with

students from the Esquimalt Leadership Class and volunteers from the Rainbow Kitchen to run a very successful community booth at both Buccaneer Days in May and the Esquimalt RibFest in September. Last year these two weekend events saw a total of over \$9000.00 raised and this year a similar amount was collected. The three groups participating have each received over \$6000 for their organization. The financial return is only part of the good news.



The three groups provided 14 to 18 volunteers to work at each event to prepare and sell fresh Langos (better known as beaver tails to some) along with pop and water. The positive interaction between all volunteers is the real story behind the success. A further benefit is that the students and Alumni members have develop better understanding about



the great work that is undertaken at the Rainbow Kitchen. In fact, some of the students have chosen to do some of their required school volunteer hours at the Kitchen. We expect to see this three way partnership continue at both these community events next year.

Scholarships:

Two more scholarships will be given to deserving EHS students at the AGM of the Alumni Association on November 20. This will bring the total to 20 scholarships that the Alumni Association has awarded over the last 11 years. Starting with \$500 scholarships the first few years the amount now awarded is \$1000 for each student. Over the 11 years of this program \$15,500 has been provided to young people for their post-secondary education. The members of the Alumni Association have generously donated funds to the scholarship account which now has about \$29,000 in it. The Alumni Executive at their last meeting voted to increase the number of awards next year to three scholarships of \$1000. A big thank-you to all those members who have assisted with the development of this fund and if you wish to make a contribution this year there is a donation form contained in the AGM material attached to the newsletter. All donations over \$20 receive

a tax receipt and are very much appreciated.

<u>Alumni Association and Funding Society Bylaw & Constitution Changes</u> by George Copley

The BC Government enacted a new Societies Act on November 28, 2016, which updated and modernized the Act and provided that all documents in the Registry MUST be filed electronically. One consequence of this new Act is that the constitution and bylaws of every society in BC (some 25,000 societies large and small) have to be refiled electronically to replace the old paper files. Failure to do so within the two years allowed (ie by November 28, 2018) will result in the delinquent society being struck from the Registry and no longer having legal status.

A subcommittee of members of the Board of the Alumni Association and the Board of the Funding Society has been working over the last year to prepare the constitutions and bylaws of both societies for electronic filing. This has presented an unique opportunity to modernize and revise the bylaws and change the name of the Funding Association to a simpler name, the Esquimalt High School Alumni Association. In order to carry out these revisions several special resolutions will be introduced at the AGM's on November 20, 2017.

EHS ALUMNI ASSOCIATION 2017-2018 FUNDRAISING DRIVE



The Alumni Association wishes to focus on raising money for the Scholarship Fund and instrument replacement for the Music Department this coming year. We are asking members to donate to one or both of these projects. The Scholarship Fund is currently at just over \$29,000. We are currently presenting two \$1,000 scholarships each year. The goal for the Scholarship Fund is to get to over \$30,000. In the future, we expect to increase our scholarships to 3 scholarships one year and 2 scholarships the following year. As well this year we are hoping to assist the Music Department upgrade their musical instrument inventory. This will cost about \$15,000.
