## 1. Call to Order.

#### 3. Treasurer's Report

Dave reported that the donations for this year were still well down with a total of \$1445.00. This was split between scholarship - \$850.00 and new music equipment -

Dave also reported that the scholarship account was quite healthy with a balance of just over \$28,000 including the donations from this year. This total was not including the interest, which is added at the end of June 2018 or the funds in trust from Kiwanis club and Esquimalt Writers Group for their scholarships. The actual amount in the account will be available by the end of August 2018 when the School District updates the account. Dave provided the committee members with a summary of the Scholarship Account (attached to minutes).

## 4. Booth at Buccaneer Days

The school leadership group along with another group of students will be running the langos booth at Buccaneer Days. Dave will assist and get some alumni help at the booth. Barry will have some merchandise for sale also at the booth. The booth will operate Saturday May 12 from 11:00 am to 5:00 pm and Sunday May 13 the same hours. Dave will be available for set-up and take down.

## 5. Sale items at RibFest

Barry reported that he has a supply of t-shirts and scarves, but nothing else for sale. Dave said he would check with Chasity at the school to see if there were some items that we could have or take on consignment. He would report this at the next meeting.

## 6. New Field Fund

Tammy reported that there was almost \$150,000 in the Turf Field Fund. Unfortunately, it is only getting about 1% interest. Tammy was asked if she could get information about investing these funds as they would not be used for at least 2 years. She will report at our next meeting.
