Meeting brought to order by KH at 6:47pm.

- 3. Review and approval of Agenda

- 4. Approval of February 9, 2020 General Meeting minutes Motion to approve CS; Seconded KC. Motion carried.
- 5. Administration Report Vicki Roberts
 - a. Capstone Project Ange Coutts

This is the first year for the Capstone Project, a graduation requirement under the new curriculum and worth 2 credits. Students complete a passion project (40pts), documenting their process (30pts) and reflecting upon their learning (30pts). Students are coached by someone within the school community with whom they have a connection (e.g. counselor, case manager, teacher-mentor). The work culminates in a 'Gala', where projects are presented to the public. This year's gala will be held May 5 under public health guidance.

If, for whatever reason, a student is unable to complete the full responsibilities of a capstone project, the "SOS" option is offered. Here, the student must complete three 5-year plans, create a budget, attend a 'reflection' appointment, and attend the gala event (or one of two make-up sessions for said gala). This will earn the student a grade of 50% and meet graduation requirements.

The next deadline is April 21, when students have a 15-minute check-in with their coaches. Any questions can be directed to acoutts@sd61.bc.ca

Q: Can the Alumni Association be of assistance?

A: Yes! The hope is that the greater public (including our alumni friends and media) be invited to the annual Gala event – under the health guidelines of the day. Funding would be greatly appreciated for food. A formal funding request will be made to the Esquimalt High School Alumni Association by Ange Coutts.

Q: Are the coaches paid for this work?

A: The coaches volunteer their time outside of paid hours, but there is a small pot of money allotted for teacher "release time". Administration staff are not remunerated for their coaching time. There are currently 29 volunteers. Ange

Coutts manages the coaches and oversees the project and is paid one block of teaching time.

b. Graduation volunteer hour requirements

Administration is being flexible with this, given Covid-19 public health guidance.

c. Graduation events

To be held June 19. Planning is underway; likely to be another car parade/drive-thru diploma ceremony.

d. 2021-2022 Timetable survey

Results: 51.6% of Parents rated the overall 2020-21 experience as "good"; Parents were 'somewhat' (44.1%) or 'very satisfied' (30.8%) with the quarter semester system; 62.4% want to know the 2021-22 timetable in advance and want it to remain consistent all year.

Q: Will the quarter semester system stay on after the pandemic is over?

A: All administrative changes that occurred during the pandemic will be reviewed to determine if they are worth keeping. Here is some of the feedback we received:

Q: Will the late start in the day be retained?

A: Administration heard loud and clear that students and parents liked the late start. A late start would mean cutting back hours elsewhere (e.g. lunchtime) due to contractual obligations with teaching staff.

Deadline is April 30 for parents/students in Grades 10, 12.

g. Musical

Production is being filmed and should be ready by early June. ACTION (CS): Remove call for volunteers from Facebook page.

- h. Federal Covid funding
 - Allows for 1.0FTE to help students struggling academically.
- i. Summer school will not be offered by SD61 in 2021.
- j. District Financial Budget for 2021-2022
 Being discussed at SD61 special meeting on April 13, 2021. Challenging time for teachers.

Q: Are Esquimalt parents weighing in, either to administration or to the PAC Executive?

A: Administrators are redirecting parents to SD61. PAC Executive has not received communication from parents. The Esquimalt Music Parents Association is contacting parents/guardians directly regarding proposed cuts to the Music program.

6. Open Question Period

Q: Are any staff on stress leave?

A: Some staff are on a leave of absence, but the administration cannot comment on the nature of the leave.

Q: Are you anticipating turnover in personnel next year?

A: Esquimalt High teachers are exceptionally loyal; turnover rates are low relatively speaking. That said, finding qualified French Immersion teachers is always a challenge.

Q: Were all parents notified regarding the decision not to run the book club for Dr. Shimi Kang's books?

A: Unsure. ACTION (VR): Look into whether the cancellation was communicated to interested parents.

Q: What is the official position regarding the decision not to share member contact information with the school's PAC?

A: Unknown. ACTION (VR): Find answer and report back to the PAC Executive.
